STUDY PLAN

In general, double degree students take all course work required to obtain both degrees without extending the standard study period of four semesters. Therefore, please make sure to plan your course of studies thoroughly as early as possible (according to the plan below).

You will spend the first and second semester in Mannheim, where you will take the five core courses of the MMM, as well as well as electives and a research seminar (7xx module) in order to fulfill the requirements for writing your master thesis. Details can be found in the MMM module catalog.

During the third and fourth semester you will study at ESSEC with course work worth at least 60 ECTS, including both core courses and electives.

4) It is required to attend 5 cross-disciplinary courses (SPOC): Responsible Leadership (equivalent to CC504), Climate Change, Diversity and Inclusion, Entrepreneurship, Artificial Intelligence. These course cannot be transferred to the MMM.
