STUDY PLAN

In general, double degree students take all course work required to obtain both degrees without extending the standard study period of four semesters. Therefore, please make sure to plan your course of studies thoroughly as early as possible (according to the plans below).

You will spend the first and second semester in Mannheim, where you will take the five core courses of the MMM (28 ECTS), as well as the course MKT 545, one business administration module from the Area Management (min. 6 ECTS), and electives (of at least 14 ECTS) from the Business Administration offer as well as the elective Business Law and within that the module European & International Business Law where you have to complete minimum two out of six courses (min. 6 ECTS). During the second half of your studies at LUISS in Rome you will also take courses worth at least 60 ECTS, including two courses on sustainability and two elective courses.

4) You cannot do a curricular for-credit internship as part of the double degree program, but you will do the project work as a mandatory activity. You are allowed to do an extracurricular non-for credit internship.

MASTER THESIS

The master thesis is executed at and supervised by LUISS. A defense at one of three yearly dates is mandatory. The thesis will be transferred together with the project work with 24 ECTS to Mannheim.

SEMINARS/LANGUAGE COURSES

Please note that pass/fail seminars and language courses cannot be transferred to the MMM; to achieve the 120 ECTS degree requirement it might be necessary to complete an additional course at Mannheim or LUISS.
