- 120 ECTS in 2 years
- > Two university systems, different teaching styles
- ➤ No extra tuition for a double degree program/ but administrative fees
- Boost your international network and career opportunities




Double Degree – Credit Transfer



Application Process



Deadline: October 9, 2020

- Possible to apply for up to two double degree programs (one application/two letters of motivation)
- Pre-selection and interviews: in October (rolling process)
- Final Decision: end of October/beginning of November
- In case of admission accept within 4 days on Mobility Online

Most important tool: Application guide on the website



Application Documents



- 1. Online application form, generated in Mobility Online
- 2. CV (English)
- 3. Letter of motivation (English) /one per program
- 4. Study plan (preliminary) /one per program
- 5. Bachelor's degree certificate/Transcript of records
- 6. GMAT or GRE result (unofficial GMAT score report is sufficient)
- 7. Proof of English language proficiency
- 8. Optional: Proof of language of instruction at the partner institution (if different from English)
- 9. Optional: Other relevant certificates
- 10. Optional: Passport
- 11. Optional: Picture
- 12. Consolidated PDF file



Selection Criteria



- Personal and professional motivation and eligibility
- Good to very good academic performance
- Very good spoken and written English skills
- Additional language skills, especially in the language of instruction (if different from English)

- Intercultural and social competencies
- Extracurricular activities and work experience
- Formal correctness of the application
- Personal impression during the interview



Regular Exchange Semester



- Advice: Apply for both the double degree program and a regular exchange semester (deadline October 31, 2020)
- ➤ Please note: If being accepted in the double degree program, application for regular exchange semester will not be considered any longer.
