

More practical

The slides are very unstructured, if you weren't able to attend class and take notes, there ~~is~~ important information missing or extra explanations. More practice questions for exam.

Clearer and more structured content of the classes

Structure of topics on lectures. Some topics showed up scattered over several lecture slides. More difficult to learn.

- Provide more exam preparation material (e.g. old exams)
- Better structure the slides by the individual theories & models
- Better sync the schedule of the lecture with that of the case study course
 - really confusing structure of slides, or the slides it was jumped between different concepts
 - made it really difficult to follow the structure of the slides
 - the slides were not well-structured & sometimes confusing

The course is too difficult to understand. And there is no exercise session to help us prepare for the exam. The theories seem to be useless and should belong to PhD course.

We deserve more credits from this course. Some students actually don't have too much financial background before. It would be great if we can have some elementary course for corporate finance in order ^(tutorial)

- longer breaks or shorter sessions as it is almost impossible to focus for 3h or longer (particularly during the time when there were additional tutorials scheduled)
- more refreshment of basics or refresher introductory course
- offering of exercise classes

Separate session should have been devoted to "cost of debt" topic. Additionally, tutorials could be conducted for problem solving so that students can learn how to solve questions/exercise and get better preparation before case studies.

- less research and instead more practical or numerical examples

More interaction between the instructor and students is expected.

More exam preparation material:

- Mock exams
- more exercises
