

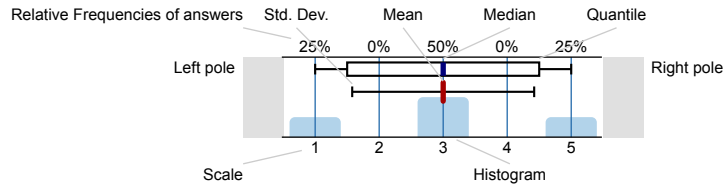

- I think it will be better if there is a course summary. I can not link different lectures and it is difficult for me to understand the whole structure of corporate finance.
- I would be interested in some current empirical evidence/trend on the topics. For example, what is the current research stage about "Executive compensation" or IPOs?
- I would just like to have more of these lectures. I feel this really helps to build a general theoretical intuition that could be especially helpful for creating a model myself in my thesis. Also, no other course in the business department ever talked about structural estimation or delved this much into the theoretical intuition and I really like it.
